- Union of Professional Unions, bringing together unions and associations of medical interns in France
- 30,000 medical interns in France
- 30 to 40% of medical establishment staff





- Alternation of theoretical teaching and practical teaching
- A new stage every 6 months in the spéciality you have chosen or in a transversal one
- Lessons in university with some exams at the end : one exam per year
- The practical skills are evaluated by your hospital service (no official exam)
- During PGT most of speciality are only one the public healthcare : most of teacher are part of it
- The minister of education have announced in january 2024 that they will finance job in university for GP



- The medical interns' prescriptions are under the responsibility of the department.
- It is supposed to protect the junior doctor from legal action in case of medical error
- Some errors can be considered as « out of responsibility » of the departement in some particular cases ( consumption of alcool during work...)
- January 2024 a jurisprudence happened : a resident has been convicted because of oral prescription of morphine which had leaded to the death of patient
- While every prescription is supposed to be validated by a senior

En 2014, une surdose de morphine a causé la mort d'un patient de 80 ans. Des erreurs de jugement et la falsification de documents médicaux ont été relevés par le tribunal.

# Shortage of trainees



- Lacking of surgeons : resulting in 75h working time hour
- Lacking of general practionner : in France 87% is considered as a desert medical
- Prime minister has announced that they will open 16 000 residents versus 9000 in 2024



- Preventing the exceeding of the maximum weekly limit of 48 hours.
- Ensuring payment for overtime hours.
- Identifying the medical specialties with the longest working hours and prioritizing the creation of positions in these specialties.
- Make a link between hospital and healthcare center



- Student statut suppose to protect us
- Possibility to change the speciality after beginning of the PGT
- Teaching of our specialization and research
- Possibility to discover liberal sector during PGT
- Concerning emergency sector : rare specialization with working time account but works like a permanent night shift (life expectancy of ED is about 60 years in France)





- Non-recognition of social rights (pregnancy, parenthood, inclusion of people with disabilities)
- Difficulty in pursuing a parental project
- Financial insecurity
- Moral and sexual harassment
- No access to housing
- Duration of medical studies 10 years for a general practitioner
